


### What are tokenized assets?







Spread

This type of commission refers to the difference between the buying and selling prices of assets. As soon as the transaction is opened, the spread is written off. Different instruments have different spread values. Several factors affect the size of the commission, but the most significant is the liquidity of the instrument. Popular instruments have a much lower commission than the rarer ones. The second factor is market volatility.

• Night swap

Swap is the percentage that the trader is required to pay for those positions that are held overnight. Such payment is required only in cases where


Inaction fee

If the account is inactive for more than 90 days, then the user will be charged an account maintenance and regulation fee.

Conversion fee

If the transaction is made with a currency that does not match the user's account, a conversion fee will be charged. Such a commission is always deducted when it comes to currency conversion.



Leverage makes it impossible to trade bonds. For trading in non-leveraged bonds for tokens that correspond to these bonds, the commission is 0.05%. The storage fee for exchange-traded assets is 0.5%, or 50 USDT per year. Leveraged trading and withdrawal of tokens are free of charge.

## Compliance with legislation:





# Regulation by the European Union

CryptoKG is a tokenized asset provider licensed by the EU to create and maintain digital wallets, conduct cryptocurrency exchange operations. Our exchange regulations operate in accordance with strict EU Directives. The tokenized asset futures market CryptoKG is also operated by the Estonian EFSA. This Estonian regulator is one of the companies that give preference not to bans, but to the development of rules for the circulation of digital capital and conditions for the development of the cryptocurrency industry. Estonia is one of the first European countries to legalize crypto activities. Since March 2019, Estonia has been named the best country for doing blockchain business.

### **BIG LOSSES**

Investing with leverage means increasing your potential gains and losses. The client can incur significant losses if the price moves in the opposite direction relative to the client's expectations. To avoid big losses, we recommend using the risk management tools offered by CryptoKG. Please note: you will not be able to lose more of your account balance.

Leveraging tokenized exchange-traded assets is not a long-term investment option.

If a client holds a tokenized exchange asset for a long time, then the associated costs may increase. In this case, it may be more profitable to buy instead an underlying asset or a tokenized exchange-traded asset without leverage, which can be transferred to the client's virtual wallet identifier.

## LACK OF RIGHTS TO BASIC ASSETS

Tokenized exchange-traded assets do not grant any rights to the underlying assets.

It is necessary to invest only in those funds that you can afford to lose.

The client should not invest in tokenized exchange-traded assets funds that he cannot afford to lose. Investing in tokenized exchange-traded assets is a high degree of risk for an investor and, due to fluctuations in the value of assets, there is a possibility of incurring losses.






### CORRESPONDENCE

Any decisions about registering an account and buying tokenized exchange-traded assets, as well as whether the client understands the risks that he is taking. We have the right to request information about your financial income and assets. To assess the client's risks, we will not track the correspondence of the amounts that have been invested in CryptoKG, the information provided by the client. Only the client himself has to assess whether his financial resources are sufficient, and what degree of risk he is ready to take on.

## POTENTIAL RISKS

There is a possibility of losing all funds deposited for operations on CryptoKG, but you will not be able to lose more than your account balance. Before trading, there must be sufficient funds in the account to make the "initial size" of the leverage prepayment. For this transaction to "remain valid", make sure that the amount of funds in your account exceeds the required amount of "supported" prepayment. The initial prepayment rate differs depending on the type of tokenized exchange-traded assets. The amount required to complete a specific transaction is indicated on the CryptoKG website. Leveraged trading can work for you as well as against you: small price movements in your favor will result in high profits, and small price movements in the opposite direction will result in significant losses. Trading tokenized assets with leverage means that by making the first prepayment, you significantly increase the possible financial result from a specific transaction. Using leverage will increase the size of your trade and the potential profit as well as the potential loss will also increase. It is important to closely and actively monitor your own active leverage in order to manage the risk of large losses. # 10. Frequently asked questions

## What is CryptoKG?

CryptoKG is a platform for the provider of tokenizing assets of ECM Limited, a universal exchange providing a full range of services using cryptocurrencies. With CryptoKG, you can place long-term investments, carry out exchange operations of cryptoassets, and implement short-term high-yield trades.

# How is the exchange going?

- 1. Account registration. Click the "open an account" button on our CryptoKG exchange and enter the data in the standard form, indicating your full name, e-mail, phone number. This is a free procedure that will instantly open an account.
- 2. Account verification. To maintain the security of client accounts and in accordance with current EU legislation, it is mandatory to provide identity documents.
- 3. Exchange. After verifying your identity, you will be able to conduct exchanges. Using your bank card, you need to make a deposit in fiat money, having received Bitcoin or Tether into your account. Having BTC or USDT on your account, you can use them as a means of accumulation, keeping them for a long time, buy and sell available tokenized assets, and exchange cryptocurrencies.

## What are the opening hours?

Around the clock - the system works in automatic mode.

# How quickly will I receive BTC / USDT to my account?

It depends on whether it will be the first or the second exchange. If your account has just been verified, then on the first exchange a new wallet is created, which must be approved by the blockchain system. After that, the wallet will be available for transactions. In CryptoKG, this process often takes up to 30 minutes. If the exchange is repeated, then the process will happen quickly.





## Is it reliable?

# What are the limitations?

The minimum exchange amount is 500 USDT.
